LICENSE TO USE PUBLIC RIGHT OF WAY FOR PRIVATE DRIVEWAY PURPOSES

The City of Afton (hereinafter, "the City"), a Minnesota Statutory City, hereby grants and conveys to FOC, LLC (hereinafter, "Grantee"), a Minnesota Limited Liability Company, a license to use, for driveway purposes, that right-of-way dedicated to the City in the Minor Subdivision recommended for approval by the Afton Planning Commission on June 1, 2015 and approved by the City Council of the City on June 16, 2015, pertaining to PID#0602820240002.

The purpose of the license is to allow access over the dedicated right-of-way to Parcel B of the aforesaid Subdivision by creating and maintaining thereon a gravel driveway.

Any driveway created by Grantee on the aforementioned right-of-way shall be constructed and maintained solely at the Grantee's expense and the City shall bear no responsibility for its upkeep and maintenance until such time as a public road is constructed on the aforementioned dedicated easement.

This license shall be fully transferable by Grantee to any owner or occupant of Parcel B or their successors in interest without obtaining any prior approval by the City. This license shall expire upon the construction of a public road on the aforementioned dedicated right-of-way.

**PROCLAMATION RECOGNIZING JESSIE DIGGINS FOR HER OUTSTANDING
INTERNATIONAL ACHIEVEMENTS IN CROSS COUNTRY SKIING AND HER DEDICATED

WHEREAS, Jessie Diggins was raised in Afton, gained national attention as a cross country skier while still in high school, and became an Olympic cross country skier; and

WHEREAS, in 2012 Jessie qualified for the US National Ski Team; and

WHEREAS, in 2013, she teamed up with Kikkan Randal to win Gold in the team sprint, a historic first medal for US Women's Cross Country skiing; and

WHEREAS, in 2014, Diggins competed in the Sochi Winter Olympics and placed 8th and 13th in the cross country competition; and

WHEREAS, in 2015, she won a silver medal in the World Championships 10km freestyle in Falun, Sweden, ending a 33 year draught of distance medals for both male and female US Cross Country skiers; and

WHEREAS, Jessie is very community oriented and gives back to the community to thank all of her supporters over the years. She is an ambassador with the Fast and Female organization, which empowers young women through sport and aims to keep them involved in sport for life. She also writes a kids blog for the Minnesota Youth Ski League. Jessie also makes appearances at ski clinics, ski events and school talks throughout the year; and

WHEREAS, Afton is very fortunate and appreciative that Jessie agreed to serve as the Grand Marshal of Afton's 2015 4th of July Parade.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Afton does hereby recognize Jessie Diggins for her outstanding international achievements in cross country skiing and her dedicated community involvement.
