The stormwater drains installed in Town Square Park have been serving their purpose, but there has been erosion around the drains that has created potential tripping hazards. The recommended remedy is to do minor grading to repair the erosion and to place river rock around the drains to prevent erosion. Tri County is not available to do this work prior to the Art-In-The-Park event, so staff obtained a price quote from Croixcavating in the amount of \$450.00.

Re: Purchase of Road Salt

The City purchases its salt sand from Washington County. In 2018, while Afton was initially allocated 240 tons of salt sand by Washington County, Afton used 440 tons of salt sand. Washington County was able to provide the additional salt sand, but they were very low on salt by the time of the last snowfall.

A higher than normal amount of snow is being predicted for the coming winter. Possible salt shortages are also being predicted, as well as possible price increases. This could result in Washington County not being able to provide as much salt sand as Afton needed in 2018, or the cost could be significantly higher. To address these potential issues, staff is recommending two actions. First, staff is planning to add liquid salt to the salt sand to stretch the salt sand. Second, staff is recommending the purchase of 150 tons of salt which would translate to 300 tons of salt sand. If we can use the state contract for salt, the cost of the salt is \$77/ton. If we are not able to purchase through the state contract, the cost from an alternate vendor is \$125/ton. We have contacted Cargill, which is the state contract vendor, but they have not yet responded.

Also, there are other City activities and uses that occurred outside of both the temporary and permanent easement? It seems like you are not offering compensation for those. But don't you agree that its not fair that you select just one of the encroachments and ignore the others?

Please let me know what you are proposing to remedy those.

As to the \$4.00 per square foot-where did that number come from and are you applying it to the other encroachments and uses that occurred outside of easements elsewhere?

In the nearly 5 years that this has gone on, I have never heard from or had an invitation to meet with a councilmember representative.

Gordy,

In response to your concern about a portion of the recreational trail on the levee being on a portion of your property outside of the permanent easement area, our City Engineer has indicated it appears that about 30 sq. ft. of trail is outside the permanent easement and outside the 33rd Street right-of-way. This could be remedied by the City purchasing an additional 30 sq. ft. of permanent easement for the trail. I will recommend to the City Council that the City purchase the additional easement area at the \$4.00 per-sq. ft. amount reflected in the City's appraisal. Please let me know if this is acceptable to you.
